² GST, HST & PST

Quebec residents must pay combined PST and GST (5% GST on subtotal + 7.5% PST on new subtotal). New Brunswick, Newfoundland and Nova Scotia residents must pay 13% HST. Residents of all remaining provinces and territories must pay 5% GST.

Using UFile PRO requires registration as an EFILE Agent with the CRA (and RQ if filing returns with the province of Quebec). Registration as an EFILE agent is free. For more details regarding EFILE and NETFILE, please visit www.ufile.ca/PRO or www.cra-arc.gc.ca. **Please note:** UFile products count ALL returns, regardless of the taxpayer's income level. No NETFILE returns are included in UFile PRO. UFile PRO will be ready to download in late December or it will be ship by January 15th, 2010.
